Diversity procurement page details

The following are the top-level inputs for the diversity procurement page.

- TOTAL ACTIVE VENDORS Represents the total number of active vendors in your current report.
- TOTAL SPEND Indicates the overall expenditure, with the option to select the currency from a dropdown menu.
- CALENDAR YEAR Allows you to choose the calendar year for your report.
- FISCAL YEAR START Enables the selection of the fiscal year's starting point.
- FISCAL YEAR END Facilitates the selection of the fiscal year's endpoint.
- START MONTH Permits the selection of the starting month of the fiscal year.
- END MONTH Allows the selection of the ending month of the fiscal year.

In the image above, you can observe that for each category, you are required to input the count or number of vendors. Based on the entered quantity, the percentage will be calculated relative to the total number of vendors specified at the top level.

For instance, if you've set the total active vendors as 90,000 and added 90 as active vendors in the Small Business category, the percentage will be calculated as 0.10%, as predetermined.

The calculation for Total Spend in US\$ follows a similar process to determine the percentage. For example, if you've set the total top-level spend as \$1,000,000 and added \$5,000 for Small Business, the percentage will be calculated as 0.50%.

There are two columns for Target Spend %, where you need to select the year and input the corresponding percentage value. This is illustrated in the image above.

Just like the computation for Small Business Spend Metrics, the calculation for Diversity Spend Metrics follows a similar process. You can refer to the above section, where it details how the calculation is performed for Small Business Spend Metrics.

Diversity Certification metrics

Within the Diversity Certification Metrics section, its purpose is to determine the number of vendors certified for a specific category. You are required to input the number of certified vendors in the provided input box for each category. As mentioned in the previous two sections, where the total number of vendors for each category is specified, here you input the count of vendors holding certification. The associated percentage is then calculated and displayed alongside.

Each category will be listed, accompanied by the corresponding number of certified vendors, as depicted in the image below. Input boxes are provided for entering the count of certified vendors for each category, and based on the values entered, the percentage will be calculated.

Within this section, the sourcing type is defined at the row level, and different categories are specified at the column level. The first column contains the total count, where you are required to input the total number of vendors for a specific sourcing type. Subsequent columns represent each category of vendors, and you need to input the corresponding data. The final percentage is calculated by considering the sum of all vendors for each category, which is then divided by the total number of vendors for that particular sourcing type.

View Dashboard

Upon successfully creating and saving the Diversity Procurement report, you will find the "View Dashboard" button positioned at the top of the page. Clicking on this button will redirect you to the dashboard page, presenting various types of statistics in graphical form. For additional information, refer to the image below.
